3. Updates

- a. AACU General Education Assessment Institute team of 7 people attended. Biggest takeaway was on the use of portfolios as a learning tool and assessment method.

- c. ILO Project
 - i. Website http://www.unco.edu/institutional-learning-outcomes/. The website has been updated with the ILO survey results reports. A second draft developed by the writing team and further refined by the focus group committee was also posted.
 - ii. ILO Focus Groups/Feedback Meetings the focus group committee met over the summer to develop a schedule and protocol for conducting feedback meetings. Meetings are scheduled in the second half of September. Registration for staff participants is strong, and there are sufficient faculty registered to hold several sessions. Student registration is low, especially graduate students. Council discussed strategies for increasing student and faculty participation, including the following:

- a. Julie will send out invitations to students for people to use to recruit some students
- b. Send special invitation to HESAL program
- c. Many student services areas could help recruit students ask their employees
- d. Mark will send to Faculty Senate
- e. Will set up an open session for anyone who wasn't able to attend the others
- f. Let Kim know if interested in helping with feedback

- 1. Welcomed Mia Williams, Assistant Professor of Educational Technology and Social Foundations, as the Graduate Council representative.
- 2. Approved 9/12/16 minutes
- 3. Updates and Reports
 - a. Faculty Development Series Lyda Ellis reported the series is going well. 15 people attended the first session and 15 are signed up for the next one.
 - b. Schulze Speaker Series Proposal Kim reported that she was not able to meet the deadline. We will revisit submitting a proposal for next year.
 - c. ILO Feedback Meeting Report Kim thanked the feedback facilitators (Julie Sexton, Chris Marston, Jeremy Davis, Renee Welch, Jenna Finley, Allison Grant, and Jill Beyzak). Julie distributed a handout demonstrating how she plans to organize and synthesize the information collected.
 - d. Faculty Assessment Fellows Kim reported that the fellows are preparing to launch a study on behalf of the Liberal Arts Council to collect information about how faculty are currently assessing critical thinking in their LAC courses. They are also collecting information from other institutions about methods used to assess general education learning outcomes. Results from both activities will be used to develop a recommendation to the LAC on a method for conducting a pilot assessment next fall.
- 4. Discussion Items
 - a. Next Steps in ILO Project
 - i. The Council decided to work together at the next meeting to complete the final revisions to draft 2. Feedback from the sessions indicated that the current language is not written for students/parents.

- ii. The Council decided that an additional round of feedback is not needed. Once the draft is finalized, we will post to the website with a link for providing feedback with a deadline for consideration. We will not create a new survey but instead have a text box for general comments.
