 - 1. The mention of the EBS Dean is not needed
 - 2. Article II:
 - 1. Section 1. The Purpose of the PEC
 - 1. Remove the last sentence of the paragraph about the dean, it is already stated the Board Policy Manual (BPM).
 - 2. Section 2. Responsibilities
 - 1. Part (b) The word "program" at the end of the sentence should be "programs"
 - 2. Part (f) "and revise", revisions to PEC bylaws are not stated in the BPM.
 - 3. Part (g) is not in the BPM.
 - 4. References to BPM 2-3-107(4)(e) Missing (VII) and (VIII) from BPM, why is it set up this way?
