Chair's Report (Senbet):

Academic Policies (Levin):

- o APC is sending the Posthumous Degree Policy with revisions to Codification this week.

Salary Equity (Kyle):

- o Chair Kyle joined Cabinet and discussed giving priority to salary increases.
- o SEC values adjuncts salary increases too.
- o SEC suggests splitting the total raise pool between all faculty/staff, and adjunct faculty.
- o SEC will need to gather more regional adjunct pay data.
 - This relates to raising the base rate for adjuncts since some adjuncts are paid higher at the discretion of the specific college or dean.
- o SEC continues working on chair/director pay policy changes.

Standing Reports

Board of Trustees (Vaughan): No report.

<u>President</u> (Feinstein): Thank you to Britney for coming to the Cabinet meeting. Healthcare premium costs have risen by 12 percent, but UNC will absorb the additional cost at no cost to faculty/staff. President Feinstein met with the Joint Budget Committee and the Governor's chief of staff last week to discuss executive budgets, planning, COM funding, and funding higher education. UNC's goal is to secure as much funding as possible and have our bill roll out in

January 2024. Metro State, an institution with a similar student population, has joined UNC's funding request.

<u>Provost</u> (Fleming): The Periodic Evaluation of Administrators Steering Committee will meet next Tuesday. FPAC would also like to gather feedback from faculty and ask questions about administrative offices using an open-ended design of questions (no Likert scale). Concerns were discussed regarding faculty receiving surveys from both the Periodic Review of Administrators Evaluation Committee and FPAC. If scheduling allows, Feinstein and Fleming showed interest in discussing this with FPAC in a meeting this week. Currently, the motion to update FPAC's Bylaws is on the Faculty Senate floor.

<u>Dean's Representative</u> (Doerner): Deans were informed about degree planner data and student enrollment numbers.
