1. Call to Order

4. Chair's Report (Levin):

- Welcome to Kamel Haddad, who is serving as the Dean's Council representee to the Faculty Senate.
- In consultation with Provost Vollendorf and President Feinstein, Dean Haddad has been chosen to chair the search committee for the founding dean of the osteopathic medical school. There is faculty representation on the search committee.
- The provost search committee has selected five finalists to visit campus. We are finalizing schedules. We will host open forums for students, faculty, and staff to interact with the candidates.

5. Administrative Reports:

President's Office (Maxey): No Report.

Provost (Vollendorf): Academic Affairs is prepared to launch a search for an Associate Provost for Academic Resources and Planning. This position will play an important role in helping strengthen our ability to manage our resources and support our chairs, directors, deans, and BOMs in strategic budgeting and planning.

DISCUSSION: Enrollment outlook

- Members discussed the enrollment outlook for next semester.
- The new AVP for Enrollment Management, Pete Lien, started this semester.
- The short-term focus will be on yield: making the most of our admit pool by doing everything we can to make sure the students admitted to UNC attend UNC.
- Academic Affairs is working to support deans/colleges by providing data to help with academic budget modeling.
- Graduate students have increased in proportion to undergraduate students (30% GR to 70% UG).
- Strategic enrollment management planning will be crucial to stabilizing enrollment.
- Academic Affairs is planning a retention summit later this year, which will be an opportunity to speak broadly about retention and what we can do better.
- A new transfer and transition center will launch later this year.

Board of Trustees (Fischer): No Report.

Professional Administrative Staff Council (Cobb): We are inviting college deans to PASC meetings to discuss staff retention/turnover numbers. In February, we will have a Valentine's Day-themed decorating contest.

Academic Policies (Vaughan): We are working on a Leave of Absence policy for the Graduate School and updates to the Posthumous Degrees policy. We also have a couple minor catalog items to bring to Faculty Senate next time.

Faculty Welfare (Senbet): We are continuing work on chair/director roles.

Salary Equity (Greene): We have an item under new business.
