Pet-Sitter Release Form

As a member of the Pet Friendly Community, I understand it is my responsibility to always care for my pet. If there are circumstances that require me to be away from my pet for an extended period of time, it is my responsibility to designate a care provider for my pet (must be a UNC residential student). For each period of time, I must be away, a “Pet Sitter Release Form” must be completed and turned into my community Residential Coordinator. Forms must be submitted at least one week in advance.

This form is intended for pet sitting access while a resident is away for a short period of time (i.e., a weekend trip.) Pet sitting forms are not intended for regular animal care and abuse of the form may result in revocation of pet approval. Residents with an animal are responsible for the regular care of their animal including feeding, waste removal, walking, etc.

The designee will be granted access to the apartment/room of the pet owner to care for the pet for the dates specified above. The Pet Sitter will need to obtain a lockout card and/or key for the hall at the neighborhood desk for the duration of pet-sitting described in the “Dates of Absence” above. Do not give your card/key to the Pet Sitter. All responsibility for the care of the pet remains with the owner of the pet even when absent from the hall.

I acknowledge and accept the following terms of granting access to a third-party designee who will be serving as a pet-sitter in my absence (please initial all):

____ I am fully responsible for the behavior of my pet in and around the halls. I am responsible financially and judicially if there are concerns/violations/damages caused by my pet; I understand I and/or my pet could be asked to leave the community if behavior is repetitive or severe.

____ I am responsible for conveying all rules and expectations regarding the disposal of all waste from my pet in the appropriate containers with my designee.

____ I am responsible for conveying all rules and expectations regarding my pet not being permitted in common spaces within the hall/community, including lounges, dining halls, and other residential spaces outside the established floors (exception of the lobby when entering and exiting the hall) with my designee

____ I am responsible for conveying all rules and expectations in regard to my pet being on a leash at all times when entering and exiting the building and care will be taken within the community to ensure safety of all people and animals with my designee.
